## A Petition to the Supreme Court of the United States from the People of the United States

To the Honorable Justices of the United States Supreme Court:

We, The People of the United States, humbly petition you to redress and correct the grave injustice and the crime against humanity which is being perpetuated by your decisions in Roe v. Wade, Doe v. Bolton, and Planned Parenthood v. Casey (the abortion cases).

WHEREAS: The United States Supreme Court committed a grave injustice and a crime against humanity in the Dred Scott (slavery) decision by denying personhood to a class of human beings, African Americans; and

WHEREAS: The Supreme Court committed a grave injustice and a crime against humanity by upholding the "separate but equal" doctrine in Plessy v. Ferguson which withdrew legal protection from a class of human beings who were persons under the Constitution, African Americans; and

WHEREAS: A crime against humanity occurs when a government withdraws legal protection from a class of human beings resulting in severe deprivation of their rights, up to and including death; and

WHEREAS: In Brown v. Board of Education, the Supreme Court corrected its own grave injustice and crime against humanity created in Plessy v. Ferguson by reversing and abolishing the 58 year old "separate but equal" doctrine, thus giving equal legal rights to African Americans; and

WHEREAS: Under the doctrine of stare decisis the three abortion cases mentioned above meet the test for when a case should be overturned by the Supreme Court because of significant changes in facts or laws, including but not limited to the following:

- a) The cases have not been accepted by scholars, judges and the American people, as witnessed to by the fact that these cases are still the most intensely controversial cases in American history and at the present time.
- b) New scientific advances have demonstrated since 1973 that life begins at the moment of conception and the child in a woman's womb is a human being.
- c) Scientific evidence and personal testimonies document the massive harm that abortion causes to women (see <a href="www.operationoutcry.org">www.operationoutcry.org</a> and <a href="www.afterabortion.org">www.afterabortion.org</a>).
- d) The laws in all 50 states have now changed through Safe Haven laws to

- eliminate all burden of child care from women who do not want to care for a child. See <u>nationalsafehavenalliance.org</u>.
- e) Public attitudes favoring adoption have created a culture of adoption in the United States with many families waiting long periods of time to adopt newborn infants.

BE IT RESOLVED: We urgently plead with you and pray to the Lord Jesus Christ for the United States Supreme Court to do the right thing, as you did in one of your greatest cases, *Brown v. Board of Education*, which overturned a 58 year old precedent of the United States, and reverse, cancel, overturn and annul *Roe v. Wade, Doe v. Bolton, and Planned Parenthood v. Casey*.

## An Explanation of the Petition to the Supreme Court of the United States, From the People of the United States

The purpose of the petition to the Supreme Court is to provide an outlet for the people of the United States to show their Supreme Court they do not accept the decisions in *Roe v. Wade, Doe v. Bolton and Planned Parenthood v. Casey*. This petition will demonstrate that over a million Americans know that abortion is a crime against humanity and can never be accepted by a just society.

In 1992, in *Planned Parenthood v. Casey*, the Supreme Court did not overrule *Roe* and *Doe* because the Court stated that Americans had come to rely upon the cases and the Supreme Court was going to settle the abortion controversy for all time. Obviously, the Supreme Court failed to settle the controversy. **Abortion is still the most controversial issue in American society today.** This petition will give each American a mechanism to petition their government for redress of grievances.

There are significant reasons why the Supreme Court should do the right thing as the Supreme Court did in *Brown v. Board of Education* and reverse the crime against humanity it created in *Roe* and *Doe*. *Planned Parenthood v. Casey*, which weakened but did not reverse *Roe* and *Doe*, has been called the worst constitutional decision of all time because it placed the reputation of the Supreme Court above the lives of innocent children. The petition correctly identifies abortion as a crime against humanity. It also educates Americans to the fact that there is another mechanism that women can "rely upon" for birth control rather than abortion through the Safe Haven laws which are now available in all 50 states. She can transfer responsibility for the child to the state by simply dropping the child off at a state approved location within a reasonable time after birth. See www.nationalsafehaven.org. This is a "change in the law" since 1992, the last time the Court evaluated *Roe* and *Doe*. Safe Haven laws were not present in 1992. The Supreme Court is justified in overturning precedent when facts, circumstances and law have changed that make the original decision no longer just, even if it ever was, which *Roe* and *Doe* were not.

Plessy v. Ferguson which made the separate but equal doctrine the "law of the land," was a 58 yr. old precedent of the Supreme Court. This decision was a crime against humanity just as Dred Scott (slavery) was a crime against humanity by withdrawing legal protection from African-Americans. All Americans can and should join this petition to the Supreme Court created

by The Justice Foundation for you and others. It is a right of citizens to petition their government for redress of grievances.

Why petition the Court? This is an unusual step, but ending a crime against humanity justifies unusual action. The people of the United States did not vote for *Roe v. Wade*, instead the Supreme Court created the crime against humanity which is *Roe*, *Doe* and *Planned Parenthood v. Casey*. It is the Supreme Court which must be petitioned by the people to change its decision. It is also right and just to give the Court the opportunity to correct their own error.

Judges have petitioned the Court to re-evaluate these cases which the Supreme Court has refused to do. See *McCorvey v. Hill*, 385 F. 3d 846 (5th Cir. 2004). Recently, the 8th Circuit Court of Appeals in a unanimous decision urged the Supreme Court to reverse its decision in these cases. See North Dakota case: *Wayne Stenehjem, et al v. MKB Management Corp., et al*, 795 F.3d 768 (2015).

While this petition alone cannot mandate the reversal of *Roe v. Wade*, *Doe v. Bolton* and *Planned Parenthood v. Casey* by itself, it can encourage the Supreme Court to exercise its discretion under the *Writ of Certiorari* to accept a case in which it could evaluate the facts and law in a fair and impartial manner and reach a conclusion that achieves justice by reversing its crimes against humanity.
